Subject: Proposed arrangements for the 31st Session of the IOC Assembly

In my capacity as IOC Chairperson, I would like to follow up on the decision <u>EC-53/6</u> adopted by the IOC Executive Council at its 53rd session (3–9 February 2021), requesting that IOC Member States be consulted on the perspective of holding the 31st session of the IOC Assembly around the timeframe originally designated by the Assembly at its 30th session, i.e. over the period from 14 to 25 June 2021, recognizing the uncertainty that the Covid-19 pandemic still poses on the meetings *in praesentia*.

Following the online meeting of the IOC Officers and encouraged by the success of the on-line session of the Executive Council, I would like to invite you to hold the Assembly session online over the above-mentioned period, with one notable exception on one day – the 21st June 2021 - when the elections will be held *in praesentia* at the UNESCO Headquarters in full adherence to the IOC Rules of Procedure.

The draft agenda and preliminary timetable for the session focussing on items requiring decisions from the Assembly are attached herewith for your consideration.

Under the circumstances, the Officers recommend that the Ocean Science Day and IOC Memorial Lectures be exceptionally suspended this year, in order to allow optimal time for discussions and decision-making.

I welcome your comments on this proposal **by 31 March 2021 at the latest**. The Executive Secretary's communications will follow shortly after, along with all the technical guidelines aimed at facilitating your effective and efficient participation.
