Subject: Tenth meeting of the ICG/PTWS Regional Working Group on Tsunami Warning and Mitigation System in the South China Sea Region (ICG/PTWS WG-SCS), 28 & 30 September 2021 (0700-0830 UTC, online)

The Intergovernmental Coordination Group (ICG) for the Pacific Tsunami Warning and Mitigation System (ICG/PTWS) was first established by the IOC in 1965 as a cooperation mechanism for countries in the Pacific whose coastal areas were threatened by tsunamis. Through the ICG, Member States have designed and developed the Pacific Tsunami Warning and Mitigation System and work together since to improve and sustain it. At its 28th session in April 2019, the ICG/PTWS decided to continue the Regional Working Group on Tsunami Warning and Mitigation System in the South China Sea Region under the chairship of Mr Chan Sai-Tick (China).
