- 1. Advocate seismic data sharing in the region;
- 2. Advise Southwest Pacific countries on data sharing protocols, techniques and technologies;
- 3. Work with SWP countries and donors to ensure a common data sharing policy;
- Encourage Southwest Pacific countries with existing or planned broadband seismograph stations to (i) join the International Federation of Digital Seismograph Networks (FDSN), (ii) use the standards developed by the FDSN for data exchange, and (iii) take advantage of the data archiving provided by FDSN.

The ICG/PTWS WG 2 Task Team on Seismic Data Sharing in the Southwest Pacific is composed of representatives of South Pacific countries and territories (Australia, Fiji, France–French Polynesia, France-New Caledonia, New Zealand, Papua New Guinea, Samoa, Solomon Islands, Tonga, Vanuatu), with PTWC, NWPTAC, Japan, the United States of America and Council of Regional Organizations in the Pacific (CROP) and WMO Regional Association (RAV) as observers. The Task Team is co-chaired by Messrs Rennie Vaiomounga (Tonga) and Matthew Mohoi (PNG).

The Tsunami National Contacts (TNCs) of the above-mentioned countries are invited to nominate delegate(s) to the Eighth meeting of the ICG/PTWS-WG 2 Task Team on Seismic Data Sharing in the Southwest Pacific.
