With this Circular Letter, I am pleased to invite the Tsunami National Contacts (TNC) of the NEAMTWS to nominate experts with the required expertise according to the Terms of Reference of each Group (see Annex 3) to participate in the work of the above-mentioned Working Groups and Task Teams.

The following rules and conditions apply to all Working Groups and Task Teams of the ICG/NEAMTWS:

- Working language: English
- Frequency of meetings: As required and determined
- Coordination and Elections: In accordance with the rules of procedures applicable to IOC Subsidiary Bodies, unless nominated by the ICG/NEAMTWS, a chair and at least one vice-chair shall be elected by the members of each Working Group and Task Team for

the intersessional period of two years with the possibility of re-election for one term in the same position

- Members and appointment: Nominated by Member States in accordance with the rules of procedures applying to IOC Subsidiary bodies. Technical experts and observers can be invited at the discretion of the Chair
- Programme of intersessional work should be determined by the working groups and task teams at their meetings and included in the report to the ICG
- Duration of the Working Group: Two years, renewable subject to review by the ICG. Task teams should be disbanded by the ICG/NEAMTWS once the tasks assigned to them have been completed
- Reports: A progress report on the work of the groups should be submitted two months before each ICG session and within two months of each working group and task team meeting
- Financial resources: Participation in the working groups and task teams and attendance at meetings will be at national expense.

- <u>25 October</u>: deadline for the online registration of delegates;

3/ Terms of Reference of the ICG/NEAMTWS Working Groups and Task Teams

Terms of References for Working Group 1 on Tsunami Hazard and Modeling

The working group will be responsible for providing information and proposing standards for modelling techniques in support of tsunami early warning, sea level related hazard, and coastal inundation. It proposes, facilitates, and supports efforts to homogenize model output and recommends best practices in the production of hazard maps for planning purposes of coastal communities. It interacts with other working groups to provide expertise in utilization of data for forecasting purposes and in adequate interpretation and utilization of modelling results.

Terms of References for Working Groups 2 and 3 on Seismic and Sea Level Measurements

The working group will be responsible for:

- i. Defining, based on existing organizations and functions, detection transnational networks, like seismic, geophysical and sea-level/marine networks as part of early warning tsunami detection instruments;
- ii. Providing recommendations on the data processing and analysis;
- iii. Providing a list of possible sea level stations for the NEAMTWS.

Terms of References for Working Group 4 on Public Awareness, Preparedness and Mitigation

The Working Group will advise on the assessment of vulnerability and risk to communities in respect of tsunami events; on procedures for enhancing awareness of, and preparedness for tsunami impacts including evacuation planning and education; on the receipt and interpretation of tsunami alert messages received from Regional Tsunami Watch Centres by Tsunami Warning Focal Points and National Tsunami Warning Centres for issuance of warnings to threatened communities; and on the options in an Integrated Coastal Area Management (ICAM) context for the mitigation of risk to communities in respect of tsunami impacts.

TASK TEAMS

Terms of Reference of the ICG/NEAMTWS Task Team on Documentation

The Task Team will:

- i. Coordinate inputs from Tsunami Service Providers (TSPs), Working Groups and the Task Team on Operations and the Technical Secretariat to produce the NEAMTWS Strategy and Operational User Guide (OUG);
- ii. Report to ICG/NEAMTWS Steering Committee in March/April 2024 and subsequent ICG/NEAMTWS session.

Terms of Reference of the ICG/NEAMTWS Task Team on Tsunami Exercise

The Task Team will:

- i. Finalize NEAMWave23 Evaluation report in the second quarter of 2024;
- ii. Work on the preparations of the next NEAMWave exercise.
- iii. Update the NEAMWave Exercise Manual and online forms for subscription and evaluation, in collaboration with the ICG/NEAMTWS Secretariat;
- iv. Support the ICG/NEAMTWS Secretariat in the organization of online meetings for exercise preparation.

Terms of Reference of the ICG/NEAMTWS Task Team on Operations

The Task Team on Operations will facilitate improvements and harmonization of operational implementation of warning centres/systems through:

- i. Continue to improve the Performance Monitoring Framework for NEAMTWS upstream components, based on the functions-requirements defined in the approved accreditation procedure and performance indicators developed for Communication Test Exercises;
- ii. Advice on the modalities of operation, interoperability, methods and standards for the development and issuance of warnings, such as methods and reporting of magnitudes, and requirements in terms of coordination and operation of NEAMTWS;
- iii. Foster and propose a technical solution for real-time data exchange among TSPs and possible new CTSPs;
- iv. Evaluate the recommendations made by the inter-ICG/TOWS Working Group on Tsunami Operation for possible implementation by ICG/NEAMTWS;
- v. Advice on arrangements for redundancy and back-up arrangements;
- vi. Support the Task Team on Documentation;
- vii. Continue the assessment of the Global Service Definition Document and investigate its adaptability by the NEAMTWS and report progress to ICG/NEAMTWS-XVIII.

Terms of Reference of the ICG/NEAMTWS Task Team on Tsunami Ready

The Task Team on Tsunami Ready Team will:

- i. Promote the Tsunami Ready Programme in the NEAM region and encourage Member States to join the program;
- ii. Coordinate and foster cooperation among NEAM countries and other regions worldwide on the Tsunami Ready Programme in place, as well as exchange knowledge, experiences and best practices;

- iii. Provide advice on the procedures to achieve a Tsunami Ready recognition;
- iv. Adapt the standards in NEAM region according to the IOC UNESCO Tsunami Ready guidelines;
- v. Report to and have a strong interaction with the ICG/NEAMTWS/WG4.

Terms of Reference of the ICG/NEAMTWS Task Team on Non-Seismic Tsunamis

1. To explore potential approaches to assess hazard, monitor, and to warn for non-seismic tsunamis (e.g., volcanoes, landslides including earthquake-induced landslides, meteotsunamis).

2. Identify critical areas in the NEAM region which may serve as test cases to guide future risk management measures.
