#### Subject: Invitation to the Fifteenth Intergovernmental Session of the IOC Sub-Commission for the Western Pacific (WESTPAC-XV), Tokyo, Japan, 11–13 March 2025

I have the pleasure of inviting you to participate in the Fifteenth Session of the IOC Sub-Commission for the Western Pacific (WESTPAC-XV), to be generously hosted by the Government of Japan, through its Ministry of Education, Culture, Sports, Science and Technology (MEXT) from 11 to 13 March 2025 in Tokyo, Japan.

As a statutory meeting, the session will bring together national competent governmental agencies for ocean, marine scientific communities and other relevant ocean stakeholders in the region, to foster ocean science-policy interface, advance ocean science development and cooperation, enhance technical and institutional capacities, promote transfer of ocean technology, and jointly develop ocean science solutions to sustainable development in the Western Pacific and its adjacent areas.

During the session, the Sub-Commission will review its developments and achievements during the intersessional period, be updated with the international ocean-related developments, including the United Nations Decade of Ocean Science for Sustainable Development (2021-2030) and the Agreement under the United Nations Convention on the Law of the Sea on the Conservation and Sustainable Use of Marine Biological Diversity of Areas beyond National Jurisdiction (BBNJ Agreement), and then deliberate on the Sub-Commission's engagement in and contribution to those relevant international instruments and frameworks. The Sub-Commission will be expected to elect its Officers, and to formulate its programme and budget for the period 2026–2027. Kindly note that given the limited regular budget allocated from IOC, the WESTPAC Programme and Budget normally

A <u>Senior Governmental Officials Roundtable (SGOs Roundtable)</u> will be organised during the session. The Roundtable will review progress and identify challenges for the development and implementation of the Ocean Decade in the region, as a follow-up to the high-level commitments at the UN Ocean Decade Regional Kick-off Conference for the Western Pacific (2021), and the outcome document of the <u>1st Senior Governmental Officials (SGO) Roundtable</u> (4 April 2023, Jakarta). Moreover, the SGOs Roundtable will facilitate decision-makers from our Member States to exchange views and share practices how Member States recognized the importance of ocean scientific knowledge and leveraged it to inform policy and decision-making, and how the Sub-Commission could further mobilize actions in the region. In addition, the organization of <u>a National Decade Committees Forum (NDCs Forum)</u> is envisaged as a side event to the session in order to facilitate the sharing of NDC development and challenges by Member States.

A copy of the Provisional Agenda is attached for your information as Annex 1. Given the extensive agenda session scheduled over three days, I would like to kindly request delegations to focus their interventions on providing the vision, guidance, and recommendations for practical actions. Reporting on past activities will be done in writing in advance of the session. As you compose your delegation, please take fully into account the agenda, your commitments and the events that will be held, and the importance of gender equality, and the necessary engagement of early career ocean professionals in IOC meetings.

Following past practice, working and information documents, and logistics arrangements for participants, will be forwarded to you via electronic means and will be posted on the WESTPAC website (http://ioc-westpac.org/) in due course.

At this session, WESTPAC Member States will elect the Officers of the Sub-commission, i.e. one Chairperson and two Vice-Chairpersons for the next 2-year intersessional period. Elected Officers may be re-elected for one additional term of office. Information about the election procedure and prescribed nomination forms are attached hereafter as Annex 2. Kindly note that nominations should be sent to me with a copy to Wenxi Zhu, Head of the WESTPAC Office & Decade Coordination Office for the region (w.zhu@unesco.org), no later than 11 March 2025 at 17:00 p.m. (Tokyo time). As a reminder, the Chair Kentaro Ando (Japan) and Vice-Chair Aileen Tan Shau Hwai (Malaysia) currently serve their second terms, and Vice-Chair Fadli Syamsudin (Indonesia) currently serves his first term since the 14<sup>th</sup> Session (WESTPAC-XIV, 4–7 April 2023, Jakarta, Indonesia).

#### ANNEX 2

#### **Election Procedures and Forms**

As customary, at its Fifteenth Intergovernmental Session, the IOC Sub-Commission for the Western Pacific (WESTPAC-XIV), Tokyo, 11–13 March 2025, shall elect one Chairperson and two Vice-Chairpersons, for the term April 2025– April 2027.

The Chairperson shall preside over the sessions of the Sub-Commission and carry out the duties which are entrusted to him/her. The Vice-Chairpersons assist the Chairperson in his/her functions and substitute him/her where necessary. The Vice-chairpersons will be entrusted with specific responsibilities.

The Chairperson and the Vice-Chairpersons of an IOC Subsidiary Body shall not remain in his/her mandate for more than two successive terms, according to the IOC Manual.

#### Nominations

Nominations of individuals to either the post of Chairperson or the posts of Vice-Chairpersons shall be submitted by Member States through the officially designated Head of Delegation to the WESTPAC-XV or through the IOC Focal Point in the Member State or the Permanent Delegation to UNESCO.

Nominations shall be submitted in writing to the Executive Secretary using **Form A** (Chairperson) or **Form B** (Vice-chairperson). They must reach the Executive Secretary or his representative by the specified deadline for nomination.

Each nomination shall contain a declaration from the candidate that he/she is prepared to stand for the post for which he/she has been nominated and is willing to take on the obligations that would devolve upon him/her, should he/she be elected. Each nomination shall also contain a CV with the profile of the candidate (**Form C**).

Each candidate must be seconded by two Member States of the Sub-Commission other than the nominating Member State.

#### Elections

The IOC general practice is working and deciding by consensus (Rule 19.2).

Should voting be necessary, decisions shall be made by a simple majority of the members present and voting, by secret ballot (Rule 25.1).
