Subject: Invitation to the Thirty-third Session of the IOC Assembly, 25 June–3 July 2025 and Fifty-eighth Session of the IOC Executive Council, 24 June 2025, UNESCO HQ, Paris

It is my great pleasure to invite you, on behalf of the IOC Chairperson Professor Yutaka Michida, to attend the 33rd Session of the IOC Assembly. It will be held at UNESCO Headquarters on 25 June–3 July 2025. States members of the IOC Executive Council will meet for the 58th session of the Council on 24 June 2025, one day before the Assembly. In line with the IOC Statutes, this session will act as the steering committee for the Assembly.

The provisional agenda for the Assembly provides a global overview of the developments of the Commission's activity over the biennium, including through the reports of IOC subsidiary bodies. The provisional agenda and timetable attached hereto have been prepared in consultation with the Officers during their meeting in Paris, 13–15 January. In view of the technical nature of some items on the agenda, it would be much appreciated if consideration is given to the inclusion in government delegations of representatives and experts conversant with the subject matters of the session.

The Action Paper is the guiding document for the session, including the contextual information for each agenda item and a draft decision. The first version of the Action Paper will be available on the Assembly website by the statutory deadline of 25 April 2025. As customary, decisions will be reviewed on-screen and adopted immediately after an agenda item is discussed.

A form for the submission of DRs is attached.

As stipulated by <u>Rules of Procedure</u> No. 46 & 48.2, <u>supplementary items requiring a decision</u> may be submitted to the Secretariat by any Member State of the Commission or partner organization not later than 25 April 2025. Requests for supplementary items should be submitted to the Secretariat along with a short working document composed of a brief background (not more than 800 words), the action requested from the Assembly, the indication of financial implications if any, and a draft decision.

In addition to the formal plenary discussion, an <u>Ocean Science Day</u> (OSD) is organised on 30 June to discuss current challenges in ocean science, potentially with a wider audience.

The elections of the Officers of the Commission and the members of the Executive Council will take place during this session of the Assembly in accordance with the technical arrangements appended to the IOC Rules of Procedure. Candidatures must reach the IOC Secretariat at latest two working days before the day of the elections scheduled on Wednesday 2 July 2025. A webpage dedicated the IOC elections will be available on the Assembly's to webpage (https://oceanexpert.org/event/4605), enabling Member States to follow the status of candidatures received by the Secretariat

For organizational purposes, it is particularly important that IOC Members States and partner organizations first notify the Secretariat of the complete list of their <u>delegation</u> with names of the Head of delegation and representatives, with copy to their Permanent Delegation to UNESCO when relevant. In addition, Delegates and participants, including members of permanent delegations to UNESCO, are invited to register online for the session at <u>https://indico.un.org/event/1016426/</u>. Indico is an open-source meeting organization tool used by United Nations organizations. Please follow the instructions on the registration page to first create an Indico account, before registering. If you need further information or assistance, please contact the Secretariat (c/o Ms Yun Sun, <u>yu.sun@unesco.org</u> or Mr Patrice Boned, <u>p.boned@unesco.org</u> for general questions about the session).

Due to the high level of activity at headquarters during the month of June, delegations wishing to organise an event or offering a "coffee service" during the session are invited to contact the conference service or the catering service as soon as possible and inform the Secretariat for overall coordination purposes. The list of <u>side events</u> and their locations will be displayed on the Assembly webpage.

Member States are also reminded that each 'Electoral Group' will be invited to select one expert member of the <u>GOOS Steering Committee</u> for the two-year term, from 1 January 2026 to 31 December 2027, in accordance with the IOC Resolution XXVI-8 establishing the GOOS Steering Committee and noting that GOOS Steering Committee members can serve up to two consecutive two-year terms. These five experts will have the role of providing policy advice and guidance to the GOOS Steering Committee in order to align GOOS activities with decisions of the IOC Governing Bodies. Please note that the working language of the GOOS Steering Committee is English. The IOC Vice-Chairs will lead the final selection process amongst Member States of the electoral group they represent, if possible by consensus, and present candidates for appointment during the 33rd Session of the Assembly. Nominations with the candidate's CV should be submitted to the GOOS secretariat (Ms Weronika Kmiec at w.kmiec@unesco.org) not later than 30 April 2025.
