During this session, Member States will review the status of the current IOCAFRICA-VII workplan 2023–2025 (Recommendation IOCAFRICA-VII.4), consider strategic and programmatic priorities in oceanography, blue economy and management, and will address governance, budgeting, and the formation of working groups responsible for improving ocean data, information management and capacity development. The Sub-Commission will examine intersessional reports, adopt decisions for future actions, and plan activities within the framework of the UNESCO-IOC Programme and Budget framework for 2025–2027. Member States are encouraged to propose firm national commitments to IOCAFRICA's programmes in the region, guaranteeing adequate resources for their effective implementation.

IOC focal points are kindly requested to provide the composition of their national delegations (for both the session and the conference) no later than <u>5 April 2025</u>, including full names, official email addresses, designations in the delegation (Head of Delegation, Representative), and, if possible, OceanExpert identifiers (e.g. <u>https://oceanexpert.org/expert/6552</u>). Members of delegations who are also linked to an International Oceanographic Data and Information Exchange (IODE) structure, Global Ocean Observing System (GOOS) Focal Points, or members of the IOC Working Group on Sustainable Ocean Planning and Management or any other IOC group should also be indicated in the composition of the delegation. Please submit this information to Mr Ibukun Adewumi, Head of the Sub-Commission Office (<u>i.adewumi@unesco.org</u>). Please note that costs related to attendance at IOCAFRICA-VIII are borne by national delegations, though limited funding may be available for participation in the preceding scientific conference.

Elections for the IOCAFRICA Officers (one Chairperson and three Vice-Chairpersons, for a two-year term) will take place during the session. The current Officers, elected in 2023, have served two intersessional period and are not eligible to re-election. The relevant information, including nomination forms, lists of geographical groups and the list of current IOCAFRICA Officers, is attached. Candidatures, accompanied by a CV, must reach the IOCAFRICA Secretariat no later than <u>7 May 2025</u> (close of business). In this regard, we encourage consultation within geographical groups to promote gender balance and allow for election by acclamation, as much as possible.

We further invite IOCAFRICA Member States to:

- Check the contact detail of the IOC national IOC focal points and coordinating bodies for liaison with IOC at <u>https://oceanexpert.org/doclist/78</u> and use the form attached to IOC Circular Letter <u>2634</u> to communicate any updates.
- Provide information on national ocean programmes and plans, including at least one key issue that IOCAFRICA should prioritize. The Secretariat will consolidate these inputs into the IOCAFRICA workplan for 2025–2027, aligning them with national priorities. Please submit your information to Mr Ibukun Adewumi (<u>i.adewumi@unesco.org</u>) no later than <u>5 April 2025</u>, so it can be collated and distributed before the session. In order to facilitate the submission of your national ocean programmes and plans, a report template is attached below. Member States are encouraged to adapt this concise, optional template as needed.

The working languages of the session will be English and French. The draft report will be prepared in English only during the session for adoption by the Sub-Commission. IOCAFRICA Officers will present the outcomes of IOCAFRICA-VIII to the IOC Assembly at its 33rd session at UNESCO-IOC Headquarters, Paris (25 June–3 July 2025).

Nominations

Nominations of individuals to either the post of Chairperson or the posts of Vice-chairpersons shall be submitted by Member States through the officially designated national coordinating body specified for liaison with the Commission (Rule 9.2), namely through the IOC Focal Point in the Member State or the Permanent Delegations to UNESCO.

Nominations shall be submitted in writing using **Form A** (Chairperson) or **Form B** (Vicechairperson) and **must reach the Nominations Committee not later than 17:30 on 7 May 2025.**

Each nomination shall contain a declaration from the candidate that he/she is prepared to stand for the post for which has been nominated and is willing to take on the obligations that would devolve upon him/her, should he/she be elected.

Each candidate for chairperson must be seconded by two Member States of the IOC Sub-Commission for Africa and the Adjacent Island States, from different electoral groups than that of the nominating Member State. In the case of nominations for Vice-Chairperson, the two seconders should be of the same Electoral Group as that of the nominee's Member State.

Elections

Should voting be necessary, decisions shall be made by a simple majority of the valid votes cast (<u>Technical arrangements</u> 20(iv)), by secret ballot.
