# What is SOPM?

- A comprehensive strategic and **future-oriented framework** designed to guide decision-making about the sustainable use and conservation of a nation's entire ocean resources
- **Unifying umbrella** for ocean-related governance
- **Whole-of-society** and **whole-of government** approach
- Based on **robust scientific**, indigenous and local **knowledge**

# Why we need SOPM

- Accelerating pressures
- Fast growing ocean economy
- International targets
- Fragmented governance
- Limited uptake of science and knowledge in sustainable ocean decision-making -> ***IOC Foundational mandate***

# Target Audience

- **Decision-makers** and professionals **responsible for the planning and management of ocean areas** and their resources across IOC Member States
- Scientific institutions, NGOs, academia and other stakeholders

# Mission, vision & objectives

- **Vision** IOC Member States equipped to implement knowledge-based SOPM
- **Mission** Support decision-makers in implementing SOPM by facilitating uptake of data, advancing knowledge products and strengthening capacities by 2030
- **Four strategic objectives**

# Five Expected Outcomes

- **Strengthened ocean planning and management** policy approaches underpinned by science-based tools & evidence
- **Enhanced integration** of ocean observation, **data & knowledge** in decision-making
- Elevated coherence and **consistency across sectors, boundaries and the land-sea** interface
- **Increased** knowledge and **capacity** of stakeholders

# Implementation Plan 2025-2027

- **Activities**
  - Establishment of **global network of decision-makers** (end-users in the IOC value chain)
  - **Communicating SOPM & IOC's role**
  - **Map out decision-makers' science & data needs** for SOPM, including availability & gaps in IOC data
  - Sharing good practices, technical **guidance & capacity** development
  - **SOPM Pilot in 1-3 Member States**
