

Recommended a virtual meeting (in 2025) between members of the GRA council and the GOOS co-design and Coast Predict programmes and then a subsequent GRA council call to discuss opportunities for strengthened engagement and data sharing.	Secretariat	Ongoing	Emma Heslop from GOOS Secretariat made a presentation on 'Operational requirements: RRR, Co-Design, GBON' at GRA Council Virtual Meeting in April 2025.
